Exhibit Cancellation Policy: All requests for refunds must be made in writing. Written notice of cancellation received by email, fax or postmarked by April 15, 2026, will be issued a full refund minus a \$300 USD service fee. No refund or credits will be issued for cancellations received after April 15, 2026.

AFCC will, in the event of cancellation due to one of those causes reimburse exhibitors for the exhibit fees paid less all legitimate expenses incurred by AFCC in connection with the exhibits. Exhibitors are responsible for any charges incurred for any special services or requirements including, but not limited to, electrical service, power strips and extension cords, audio-visual equipment, internet, or telephone lines.

Exhibitors must confine all demonstrations and promotional activities to the exhibitor's assigned exhibit space. No signs or displays may be placed in common or conference areas, or in a way that blocks other exhibit tables. Exhibitors are responsible for obtaining any necessary state or local permits, licenses, or certificates. AFCC is unable to accommodate sharing of sponsorships or exhibit tables or conference registrations. Anyone attending a conference function must be registered for the conference and must wear their name badge at all times. Shipping instructions for exhibit materials will be provided approximately six weeks prior to the conference. All shipping and storage fees are the responsibility of the exhibitor.

A signed exhibit agreement and payment in full must be received before participation can be confirmed, or a space is reserved.
