

AFCC-AAML 2017 Conference offers continuing education opportunities as follows:

Psychologists:

California Custody Evaluators and Mediators:

- **Domestic violence training for evaluators and mediators:** Pursuant to California Rules of Court, rule 5.230(d)(1)(A) and (d)(2) and 5.215(j)(2), the outline or agenda and explanation submitted satisfies the requirements of the rule for 7.5 hours toward initial or annual DV update training.
