



# NEW PRESIDENT SAYS "LET'S BLOW OUR HORN"

I have often commented that AFCC doesn't know its own strength.

The institutional supports of the family as we have known it are being withdrawn. If that is not a crisis, it is, at least, bringing about most fundamental change - social, cultural and economic. Those of us in AFCC are at the cutting edge of the change. We are uniquely placed to witness it and, I suggest, to have a significant part in influencing its direction.

AFCC has done much to influence the change. A quarter of a century ago, when AFCC was founded by that remarkable human being, Meyer Elkin, it was thought to be a radical fringe group in its advocacy of a more humane divorce process - one which has as its priority the welfare of children and which sought to bring to the process all the insights that the many professional disciplines constituting its membership could offer.

Those then radical ideas have now become the accepted ideal. AFCC was



not, of course, alone in its advocacy, nor have its initial goals by any means been accomplished. But what has been accomplished is remarkable.

We can't rest on our laurels. We have the continuing job of bringing together and assessing the ever-developing knowledge in our field and of improving our professional skills in the light of that knowledge. But beyond that, I suggest, if we are to continue to influence the change, it is our job to bring the message of what we are learning not only to our fellow professionals but to the public at large.

There remain many jurisdictions which have not yet got the message. Few such jurisdictions are committing the funds and resources to meet the need. I don't think the public is apathetic; I think we have to do a better job letting the public know what we have learned: that adequate resources save costs.

# LOOKING BACK ON BOSTON

AFCC's twenty-third annual conference was held May 21-24, 1986 at the Copley Plaza Hotel in Boston. With nearly 400 registrants, the conference theme "Creating New Partnerships in Serving Families" was aptly demonstrated. Dr. Dorothy Huntington and Professor Frank Sander set the stage for follow-up sessions and workshops by outlining broad public policy issues for families and courts. Workshops included strategies for establishing and funding court-connected services and balancing family and individual needs. Provocative issues such as gay parenting, grandparent visitation, confidentiality and counseling the inadequate parent were discussed. A montage, "Chaos in the Court - the Dysfunctional Family", directed by Thomas Bishop, demonstrated the plight of a multi-problem family as it proceeds through the various phases and professional contacts of the divorce process. ## **UK WELCOMES AFCC**

Fifty-seven AFCC delegates and approximately 60 others from England, Ireland and South Africa met for three days of meetings at the London School of Economics following the Boston conference. Organized by Bob Tompkins (CT) for AFCC and Esther Fisher, Director of the National Family Conciliation Council of England, participants exchanged information on the state of family law and dispute resolution services in respective countries. A formal reception at the historic Law Society welcomed the visitors. Site visits were also arranged for those wishing to see a trial court and public and private program facilities. The theater was a popular attraction for many of the delegates in addition to Windsor Castle, Oxford and Stratford on Avon. Considerable interest exists in establishing an interdisciplinary organization in the United Kingdom. Several UK participants are hoping to join us at our Florida and Hawaii

conferences. The enthusiastic support and growing numbers of people joining our post conference exchanges support AFCC's international as well as interdisciplinary scope.

## **DUES INCREASE IN 1987**

The Board of Directors approved a membership dues increase to take effect January 1987. Dues have not been raised since 1980. As of mid May, 108 new members have joined AFCC. These include 79 individual, 12 student, and 17 institutional members. Additional memberships were received at the Boston Conference. New dues will be: Individual -\$ 60 (formerly \$50), Student -\$ 20 (formerly \$15), Institution -\$120 (formerly \$100), Life -\$ 600 (formerly \$500).

Estimated costs for the 18 day trip including roundtrip airfare from Honolulu, first class hotels, all meals in China, guide and translator services, tipping and porterage are \$3,497. ### **COURT NEWS**

Dane County (Madison, WI) - Revised court rules regarding mediation and custody visitation evaluations were approved by the Circuit Court Judges in March 1986. In all actions where custody or visitation of minor children is formally contested, the judge of family court commissioner shall direct the Dane County Family Court Counseling Service (FCCS) to mediate the dispute, and failing that, to conduct an evaluation. The FCCS will mediate these disputes if parents, their attorneys, the guardian ad litem (if previously appointed), and the family court counselor sign a mediation agreement. The mediation agreement provides that all meetings between parties and counselor are confidential and that the counselor will not be called to testify in Court regarding custody under any circumstances. Should the mediation process break down, the mediation file shall be sealed and a new counselor will confuct a custody evaluation.

Hennepin county (Minneapolis) -Katherine Van de Steeg became Director of Domestic Relations Court Services two years ago. Formerly Director of the Municipal Probation Division for seven years, she is able to transfer her interest in resolving child abuse and domestic violence to the family court area. Several amendments to Section 518.17 of the Minnesota Statutes may have far-reaching effects on services. As of August I, 1986, joint legal custody must be ordered by the judge at the request of either parent with the burden of denying said request resting with the objecting party. Mediation of custody and visitation disputes is strongly encouraged rather than mandated. Mediation may be provided by anyone who has completed a 40 hour certified mediation training program (although there are no standards for certification nor procedures for such). A quardian ad litem must be appointed to represent the minor children whenever there is reason to suspect abuse or neglect. Sanctions against the interruption or interference of visitation by a custodial parent include provisions for making up lost visits within a one year period of time and make up visits can be scheduled at the discretion of the aggrieved parent.

Staff are developing an orientation program which will be required of all individuals using the Court Services. The orientation program will replace the former Divorce Experience. It is expected that the orientation program will be offered several times a week.

Marion County (Indianapolis) - Ellen Scott, Director of the Domestic Relations Counseling Bureau of Marion County, successfully lobbied the passage of SB-43 which makes available an additional \$8-9,000/year for the Bureau. As of June I, petitioners will be charged an additional fee of \$15 for all divorce modification actions. The Bureau has been offering mediation services for custody and visitation disputes since January I, 1986. Disputants are referred to the Bureau for an initial assessment and orientation. Bureau staff and all nine of the domestic relations judges cooperated to produce a 20 minute video tape for divorcing family members which is shown at the orientation session. The video encourages the use of mediation services and demonstrates the evaluation and mediation processes. Patrick Phear, Director of AFCC's Technical Assistance and Tim Salius, Director of Connecticut Court Services, recently presented a three day mediaation training program for court staff.

The Michigan Association of Court Mediators recently held a day long conference for forty-five mediators and court employees. Participants focused on various techniques used to resolve

child custody and visitation disputes. The conference and the effects of mediation on easing children's adjustment to divorce were the subject of a feature article in the Morning Sun newspaper. Friend of the Court officers in Michigan have been required to offer voluntary mediation services to settle custody and visitation disputes since July 1983. More than 200 staff members, statewide, have been added to the Friends of the Court offices. New Hampshire - Diane Gill, Coordinator of the Exeter Mediation Program, predicts that by 1990 each district court will provide parent-child mediation services. Part of the reason for this optimistic prediction is the passage of SB1. This bill provides state funds to supplement start-up costs for new mediation and divestiture programs or to supplement existing programs. Family mediation provides a forum for family members to reach solutions to parent-child disputes before approaching the juvenile court for out-of-home placement.

Pinal County (Florence, AZ) -Clarence Cramer, Director of the Pinal County Conciliation Court and Presidentelect of the Arizona chapter of AFCC, states that the Local Rules of Practice have been modified by Judge Robert R. Bean to provide for a mandatory custody and visitation mediation program. The Rules attempt to standardize procedures for judicial referral to the program and provide for the distribution of information packets to the parties and their attorneys. The Conciliation Court has been providing voluntary mediation services since 1981. Mediation matters are confidential and disputants are encouraged to make use of the service on a voluntary basis. A separate custodylvisitation evaluator is assigned, unless waived by the parties and legal counsel, if mediation is unsuccessful. The mediation program is being widely publicized to the local bar and community residents.

# BOARD MEETING HIGHLIGHTS

President Tim Salius welcomed fortysix of the Board of Directors attending the annual meeting and conference in Boston. As always, the meeting was filled to the brim with the business of running the Association. Reports were received from Florida, Honolulu, Las Vegas and Los Angeles conference chairpersons and are described more fully elsewhere in this newsletter. The Board asked the Conference Committee to develop a policy on sharing of conference revenue with local host organization. The Conference Commitee recommended that revenue sharing he determined on a case by case basis and that any profits be used for chapter development purposes. Ruth Pearson-Urban

(Las Vegas) compiled a list of conference presenters and topics from 1972 to the present to assist future conference planners. Conference invitations are being sought for 1988 and beyond.

Murray Bloom, Chairperson of the Chapter and Regionalization Committee, indicated that Kansas, Florida and Virginia have expressed interest in chapter development. The existing chapter of California and Arizona continue to expand in membership and activities.

Fundraising efforts will be directed by Tom Bishop, newly appointed chairperson of the Development Committee. The Board approved a dues increase, the first since 1980, effective January I, 1987. The Board discussed ways of seeking new members and encouraging the active participation of current members. Suggestions included a new member reception at

conferences, a members' forum, surveying members' committee interests and increasing the liason with other organizations.

Michael Albano, former President of the Family Law Section of the ABA, was a guest at the Board meetings and encoaged the AFCC and ABA to work toget.

on common public policy issues.

Donald Moir, newly elected President, presided at the second Board meeting. He expressed his support of the activities begun by former President Salius and extended the Board's thanks to Tim and his staff for hosting the Boston conference.

President Moir indicated he will be seeking to broaden AFCC's horizons and in that fashion the Board approved a request by delegates from New Zealand to institute an international affiliation for groups outside the North American continent.

### **COMMITTEE REPORTS**

Academic - Elizabeth Koopman reports that the committee hopes to begin to document and describe current court services, clientele, the nature of the mediation process and resulting agreements, user satisfaction and children's adjustment post-mediation as a part of the University - Court Cooperative Research Project. Participants in the projects and additional committee members are being eagerly sought. The committee will continue its educational survey. Trainers and educators in the field are encouraged to contact the committee.

Custody Evaluation - Karen
Raiford and her committee have completed the publication "Guidelines for
Court-Connected Evaluators." The publication is available from AFCC for \$3/copy.
The committee reports the ongoing need
to feature custody evaluation presentations at AFCC conferences and to develop
a resource list of speakers and workshop
leaders on evaluation topics.

Supplements to the "Guidelines" are planned on such topics as the home call, interviewing the child, mediation after evaluation and visitation guidelines.

Mediation - Ann Milne reports that the Mediation Committee's activities have focused recently on the areas of training and education. In an effort to conduct a needs assessment of the issues in these areas, the committee sponsored an open forum or "town hall meeting" during AFCC's December 1985 meeting and at the National Conference on Peacemaking and Conflict Resolution in Denver, June 1986. A third forum will be held during the annual conference of the Academy of Family Mediators in St. Paul, July, 1986. Information and concerns emanating from these meetings will assist the committee in evaluating how best to address the needs and interests of practitioners in the field of training and education.

Publications - Chairperson Phil Bushard met with REVIEW Editor, Meyer Elkin and the Executive Director, Stan Cohen, regarding Mike's retirement and the search for a new Editor. All issues of the REVIEW have now been indexed using 190 key words. A Directory of Court Services for the U.S. and Canada is under development and several additional pamphlets are planned including "What is AFCC", "Twenty Questions About Child Support", and "Grandparent Visitation Rights". It is the committee's recommendation that AFCC separate, establish and budget for positions of REVIEW Editor and Director of Publications. This was referred to the Editor Search Committee for further study.

Public Policy - Chair Judge June Rose Galvin reports that committee responsibilities include (1) reviewing public policy issues and making recommendations to the Board as they relate to family courts and families; (2) developing model legislation in recommending adoption of legislation upon approval of the Board; and (3) monitoring legislative developments

and establishing a legislative clearing-house. The committee notes the primacy of child support issues and related questions of custody and visitation. Judge Galvin recommends that (1) AFCC direct a review of all state child support commission reports in order to facilitate making a recommendation for legislative action; (2) AFCC establish guidelines for visitation; (3) AFCC take a position on the statutory remedy of joint custody; and (4) AFCC establish model legislation on custody.

#### DIVORCE 'PIANO ACCESS' PLEA

A heart specialist in a divorce case has asked for visiting rights to his two baby grand pianos. Dr. Newton Friedman wants to play his Steinway and Bosendorfer for four hours twice a week at the home of his estranged wife Carol.

Dr. Friedman said he had been living in hotels since he and his wife separated three months ago after a 12 year childless marriage.

"The pianos have not expressed any interest in being visited by the doctor," Mrs. Friedman's lawyer said. "Although they are baby grands, we feel they are old enough to speak for themselves." - Reuter.
