



The Law and Public Policy Committee of the Society of Professionals in Dispute Resolution has completed its study of mandatory dispute resolution programs. The report "Mandated Participation and Settlement Coercion: Dispute Resolution as it Relates to the Courts", has been prepared by the sixteen member committee to present the benefits and possible disadvantages of mandated participation and settlement coercion and to make recommendations to policymakers. The committee was chaired by Ohio State Law School Professor Nancy Rogers and included practitioners, program directors, social science researchers and academics. Committee members reflect a variety of dispute resolution sectors including family, labor and employment, civil rights, community, environmental, commercial and criminal. A portion of the executive summary is presented below.

"Some jurisdictions by statute, rule of procedure, or court rule have required participation in dispute resolution processes such as mediation, summary jury trials, and courtannexed arbitration. The imposition of compulsory participation reflects views by legislatures or courts that benefits accrue to the courts, parties, or public when the use of dispute resolution procedures is not restricted to cases in which all parties agree to participate. As the use of mandatory dispute resolution has expanded, a variety of public policy issues have emerged.

Mandating participation in non-binding dispute resolution processes often is appropriate. However, compulsory programs should be carefully designed to reflect a variety of important concerns. These concerns include the monetary and emotional costs for the parties, as well as the interests of the parties in achieving results that suit their needs and that will last; the justice system's ability to deliver results that do not harm the interests of those groups that have

historically operated at a disadvantage in this society; the need to have courts that function efficiently and effectively; the importance of the public's trust in the justice system; the interests of non-parties whose lives are affected and sometimes disrupted by litigation; the importance of the courts' development of legal precedent; and the general interest in maximizing party choice. In weighing these valid and sometimes competing concerns, policymakers should be cautious not to give undue emphasis to the desire to facilitate the efficient administration of court business and thereby subordinate other important interests. Participation should be mandated only when the compulsory program is more likely to serve these broad interests of parties, the justice system, and the public, than would procedures that would be used absent mandatory dispute resolution.

Mandatory dispute resolution raises different issues than dispute resolution chosen by the parties and should be imposed only when the following criteria are met:

1. The funding for mandatory dispute resolution programs is provided on a basis comparable to funding for trials.

2. Coercion to settle in the form of reports to the trier of fact and of financial disincentives to trial is not used in connection with mandated mediation. In connection with court-annexed arbitration, the financial disincentives, if any, are clear, commensurate with the interests at stake, and used only when the parties can afford to risk their imposition to trial.

 Mandatory participation is used only when a high quality program (i) is readily accessible, (ii) permits party participation, (iii) permits lawyer participation when the parties wish it, and (iv) provides clarity about the precise procedures that are being required. In addition, the following practices should be used in connection with mandatory programs:

- 1. Plans for mandated dispute resolution programs should be formed in consultation with judges, other court officials, lawyers, and other dispute resolution professionals, as well as representatives of the public. Mandatory programs should be monitored to insure that they constitute an improvement over existing procedures, using criteria listed in Recommendation 1. The programs should be altered or discontinued when appropriate.
- Procedures for compulsory referrals should include, to the extent feasible, case assessment by a person knowledgeable about dispute resolution procedures and should provide for timely consideration of motions for exclusion.
- Requirements for participation and sanctions for noncompliance should be clearly defined.

Court-connected Mediation Programs Need Liability Insurance

AFCC has been advised that some courtsponsored mediation programs may not be provided insurance protection under the court's liability policy. The eliminating factor in many cases appears to be the use of volunteer mediators. Some courts are choosing to self-insure this exposure; others are seeking liability insurance through AFCC's insurance carrier, Complete Equity Markets.

Basic coverage under the Mediators Professional Liability Insurance protects paid and volunteer mediators against claims resulting from mediating domestic relations disputes. Coverage is routinely broadened to include all types of mediation, mediation training services, counseling services and/ or management errors. Endorsements more specific to an insured's needs may also be developed.

Standard limits of liability range from \$100,000 per claim/\$300,000 in the aggregate to \$500,000/\$1,000,000. Limits up to \$2,000,000 per claim and aggregate are also available on a request basis.

AFCC Submits Grant for Domestic Abuse & Mediation Research

AFCC has submitted a concept paper to the State Justice Institute for funds to conduct a 26 month research project on "The Comparative Effectiveness of Mediation and Adjudication in Custody and Visitation Disputes". The purpose of the study would be to develop information for courts on the effective resolution of custody and visitation disputes in divorce and post-divorce civil actions and actions between unmarried partners where there have been instances and/or allegations of domestic abuse. This longitudinal, experimental comparison of mediated settlements and adjudicated resolutions would be undertaken to provide objective guidelines for courts to use in determining which intervention most effectively resolves these disputes. The project would be conducted in cooperation with the Urban Institute, Washington, DC. AFCC served as the convener of an international symposium on mediation and domestic abuse May 1989 and as convener of three international symposia on standards and practices for family and divorce mediators (1982-84) which resulted in the development of "Model Standards of Practice for Family and Divorce Mediators", widely adopted by public and private sector mediators across the country. 
