10 Tips to Address Family Disputes

These tips are designed to help professionals and parents effectively navigate and resolve custody disputes, ensuring that the child's best interests are prioritized while promoting cooperative and sustainable coparenting arrangements.

1. Practice Reflective Listening

Implement reflective listening techniques to ensure all parties, including children, feel their perspectives are acknowledged. Confirm understanding by paraphrasing and summarizing key points.

2. Encourage Child-Centered and Future Focused Decision-Making

Emphasize that the child's best interests should be the primary consideration in all custodyrelated discussions and decisions. Guide discussions towards prospective solutions that prioritize the future well-being of the child. Encourage planning and cooperative coparenting strategies.


Economic Wellbeing of Mothers in Shared Placement: A Cross-National Perspective

Living arrangements where children's time is shared more equally between separating parents are becoming increasingly common in the US and several developed countries in the world. Post-separation time-share arrangements determine the way child support is distributed as well as how child-related expenses are shared between parents. Moreover, these living arrangements can govern the amount of time available to parents to spend on activities outside of the household. As such, placement arrangements can have important



Mari Haapanen is a doctoral student and a researcher at the INVEST Research Flagship Centre, University of Turku, Finland. MA. Haapanen conducts cross-national research on family and child support policy with a focus on separated families and their economic well-being. Her current work is investigating the relationship between economic resources of separated families and children's post-separation living arrangements across European countries.

Trisha Chanda, PhD is a post-doctoral researcher at the Institute for Research on Poverty at the University of Wisconsin-Madison. She completed her PhD in Human Ecology from UW Madison's Department of Consumer Science in May 2023. Dr. Chanda's doctoral thesis investigates the relationship between mothers' economic wellbeing, labor force participation, and union dissolutions with a special focus on post-separation living arrangements, in Wisconsin and the United States. Her current work is investigating the incidence of low-income debt in the US and its interaction with public policy.

10 Tips to Address Family Disputes *Kelly Browe Olson, JD, LLM*

These tips are designed to help professionals and parents effectively navigate and resolve custody disputes, ensuring that the child's best interests are prioritized while promoting cooperative and sustainable co-parenting arrangements.

1. Practice Reflective Listening

Model and implement reflective listening techniques to ensure all parties, including children, feel their perspectives are acknowledged. Confirm understanding by paraphrasing and summarizing key points of all participants.

2. Encourage Child-Centered and Future Focused Decision-Making

Emphasize that the child's best interests should be the primary consideration in all custody-related discussions and decisions. Encourage planning and cooperative co-parenting strategies. Guide discussions towards prospective solutions that prioritize the future well-being of the child.

3. Teach Problem-Solving to Facilitate and Promote Effective Co-Parenting Communication

Employ and teach advanced problem-solving methodologies such as interest-based negotiation, option generation, and consensus-building techniques to promote the development of effective co-parenting communication strategies. Encourage parents to use respectful and constructive communication to discuss child-related issues.

4. Use Conflict Resolution Processes

Use conflict resolution processes such as mediation, collaborative law, and arbitration to help parents reach mutually acceptable agreements. Be aware that Intimate Partner Violence, ongoing substance use, and other competency issues might make certain dispute resolution options unworkable or require special techniques.

5. Implement Comprehensive Yet Flexible Parenting Plans

Advocate for detailed and flexible parenting plans that outline custody arrangements, visitation schedules and accommodate the changing needs of the child and parents over time. Encourage mechanisms for resolving future disputes and regular reviews of the parenting plan to ensure it remains effective and relevant for the parents and children.

6. Provide Emotional Support and Counseling and Address Emotional Dynamics

Offer access to counseling and emotional support for both parents and children to help them recognize and navigate the emotional dynamics of custody arrangements. Utilize psychological insights to help parties process emotions and maintain focus on the child's welfare.

7. Address and Mitigate Power Imbalance

Ensure that any power imbalances between parents are identified and mitigated. Depending on your role, you may need to provide additional support to the less empowered party to ensure fair participation in decision-making.

8. Educate on Legal and Psychological Aspects

Provide education on the legal and psychological aspects of custody disputes. Ensure parents understand the legal framework and the impact of custody arrangements on children's well-being. Help them think about managing disputes, not just resolving them. Develop strategies for ongoing conflict management to maintain a stable co-parenting relationship.

9. Promote Positive Parenting Practices

Encourage positive parenting practices that foster a healthy and supportive environment for the children. Provide resources and training to help parents develop effective parenting skills.

10. Evaluate Long-Term Impact and Real vs. Fake Disputes

Think about whether the dispute will matter in 5 days, 5 months, or 5 years. Prioritize issues that have a significant long-term impact on the child's well-being. Assess whether a dispute is genuine or contrived. If it's a fake dispute, consider if it needs to be resolved. Focus on resolving meaningful conflicts.



Kelly Browe Olson is an Associate Professor and the Mediation Clinic Director at UA Little Rock Bowen School of Law. She is a frequent national speaker, educating lawyers and other professionals about family dispute resolution, domestic violence, emotional intelligence, and legal issues impacting families and children. She teaches Family Law, Domestic Violence, Mediation and Family

Mediation Seminars. She oversees a state-wide Special Education mediation project and mediates family cases. She is the author of Intimate Partner Violence and Family Dispute Resolution: Coercion, Capacity and Control, a chapter in **Family Dispute Resolution: Process and Practice** recently published by Oxford University Press.
