# AFCC Board Approves Guidelines for Parenting Plan Evaluations

The AFCC Board of Directors approved the *Guidelines for Parenting Plan Evaluations in Family Law Cases* at its May 11, 2022 meeting in Chicago.

The *Guidelines* were developed over two and a half years, by a task force led by chair Arnold T. Shienvold, PhD, and reporter Kathleen McNamara. The task force also included Brian Burke, LLB; Frank Davis, PhD; April Harris-Britt, PhD; Andrea Jones, MSW, RSW; Mary Lund, PhD; David Martindale, PhD, ABPP; Aaron Robb, PhD; Leslie Ellen Shear, JD; Maureen Sheeran, BJ; Hon. Herman Walker, Jr. and Jeffrey Wittmann, PhD.

Task force members considered substantial input, including results of an AFCC member survey, public forums at AFCC conferences in Pittsburgh and Cincinnati, and more than 500 comments submitted in response to a public posting of draft *Guidelines*. The *Guidelines* will be posted soon on the AFCC website. Thanks to all of the task force members and others who provided input to the process.




# **AFCC** Awards
