AFCC Celebrates 60 Years: Everything Old is New Again



Neurodiverse Children and Parents in Family Court Psychological and Judicial Perspectives on Avoiding Bias and Negative Presumptions

As with cultural diversity and non-traditional families, neurodiversity is another social justice issue that needs to be considered in family court cases. There are unique considerations for neurodiverse children in situations of separation or divorce, who may

not do as well as neurotypical children in the common “developmentally based” parenting plan arrangements often ordered by the court. Neurodiversity in parents also presents great challenges in family court, as when a parent has a neurocognitive disability or mental health conditions, there may be an automatic negative presumption that parenting capacity will be negatively impacted by this problem. This webinar will address how viewing parents and children who have been diagnosed with neurocognitive or psychiatric conditions as neurodiverse, instead of disordered or abnormal, and viewing this diversity through a strength-based lens, reduces bias in family court. This webinar will present both psychological and judicial perspectives for family court personnel to consider with neurodiverse parents and children, followed by an interactive discussion.

Daniel B. Pickar, PhD, ABPP is board-certified child psychologist who conducts child custody evaluations, consultation to family law attorneys, and psycho-educational evaluations of children. He received his undergraduate education at Brown University and completed his Ph.D. in clinical psychology at the California School of Professional Psychology at Berkeley. For 12 years, he served as the Chief of Child and Family Psychiatry at Kaiser Permanente Medical Center in Santa Rosa, California. He has published numerous journal articles and book chapters in the areas of child custody evaluation, mediation, and children with special needs in family court. He served on the editorial board of the *Journal of Child Custody* for 6 years and currently serves on the editorial board of the *Family Court Review*. He regularly presents workshops at state and national AFCC and AAML conferences and serves on the Board of Directors of AFCC. In 2019, Dr. Pickar was awarded the Judge Rex Sater Award for “Excellence in Family Law” by the Sonoma County Bar Association.



Hon. Michelle Short was appointed to the Los Angeles Superior Court as Judge in 2018. Prior to appointment, she was elected Superior Court Commissioner in 2015. From 2015 to 2021, Judge Short heard family law matters. Prior to taking the bench, her practice was exclusively Family Law. She was regularly appointed as minor’s counsel for both neurotypical and neurodiverse families. She also worked with parties in complicated and highly contested custody and visitation issues, as well as litigated the issues of property, child support and spousal support. Throughout her tenure as a judge and commissioner, Judge Short has presented at conferences and served the Judicial Council on the Family Law Curriculum Committee, providing judicial education on the issues of Taking Testimony from Children, Minor’s Counsel, Special Needs Children, and Special Education.

AFCC Celebrates 60 Years: Everything Old is New Again

Message from the AFCC Executive Director

By any standards, the First Annual Conference of the California Conciliation Courts was an outstanding success. From the time the meeting was opened by Judge Roger Alton Pfaff on Saturday morning, September 7, 1963, until its adjournment that same evening, each participant had an opportunity to make some contributions from personal experience and to obtain first-hand impressions and observations from other counselors in the six California counties.

Green went on to name all 23 conference participants, mostly counselors, a few judges, and some invited guests. The program focused on special problems related to the establishment of conciliation courts and the character and extent of counseling services provided by court personnel. Green reported “the group discussion elicited both agreement and disagreement among members and visitors.” Judge Pfaff suggested the preparation of a Conciliation Court Manual to help guide practice.

Finally, and for our purposes perhaps most important, “... a major result of this first conference was the heartfelt need on the part of all participants to have further conferences at regular intervals. Those conferences would include all conciliation courts... as well as invited visitors and other professional people who could contribute different points of view and information to the group.”

Sixty years (and who knows how many conferences) later, AFCC has changed dramatically. The association has expanded from exclusively court personnel to more than a dozen disciplines in the public, private, and non-profit sectors. Beyond what was once a handful of California Conciliation Courts, there are nearly 6,000 members in 35 countries worldwide. Conference attendance, routinely over 1,000 before the pandemic, appears (fingers crossed) to be heading back in that direction. Over the decades, AFCC has spearheaded dozens of projects and publications that provide guidance to mediators, custody evaluators, parenting coordinators, and professionals, provided training and education through face-to-face programs, webinars, and online training programs that have been downloaded by tens of thousands of practitioners. *California Conciliation Courts Quarterly* began as a 10-page mimeographed newsletter designed to connect family court service agencies. It was ultimately replaced by two publications, AFCC's newsletter (now the **AFCC eNEWS**) with more than 17,000 subscribers, and **Family Court Review**, which is published quarterly by Wiley, and is the number one ranked family law journal, with nearly 200,000 article downloads annually.

Many things have changed, as our organization has grown from being called the Conference of California Conciliation Courts, to the Association of Family and Conciliation Courts (AFCC), with a few names in between. The name itself has been a source of discussion and continues to confound some. But as one of many participants over the years in various attempts to arrive at a new moniker, I can attest that it is much like Winston Churchill's description of democracy – “the worst form of government, except all of the others that have been tried.”

AFCC has clearly transformed in many ways over 60 years, but what might be most impressive is what has *not* changed. Because the vision of the founding members—Meyer Elkin, Stanley Cohen, Roger Alton Pfaff and others—laid the groundwork for extraordinary growth over six decades. And the hallmarks of AFCC remain the same:

- Publications that allow members to develop and share new and innovative ideas with one another. Today, they can be found in **FCR**, the **AFCC eNEWS**, and in the **Resource Center** and the **Center for Excellence in Family Court Practice** on the **AFCC website**.
- Guidance for AFCC members and other professionals, beginning with Judge Pfaff's suggestion of a Conciliation Court Manual, and evolving to a series of **practice guidelines and model standards**, and online **archived webinars** and **training programs** that inform the work of family law professionals worldwide.
- AFCC conferences continue to create a space for learning, connection, and community, serving as a catalyst for the development of new program ideas, professional relationships, and even some lifelong personal friendships.

Sixty years later, publications, practice and policy guidance, and conferences remain three articulated AFCC areas of focus. What was not necessarily identified as an early goal (but was mentioned in the first report) is the role of disagreement in AFCC. I have written before about the important **role of disagreement in AFCC**, whether it is related to intimate partner violence, shared parenting, resist-refuse dynamics, or something as mundane as why we don't serve cookies during conference breaks (spoiler alert: it keeps conference registration fees low).

An interdisciplinary community is inherently accompanied by multiple perspectives, whether derived from profession, academic background, nationality or geographic region, race, culture, socioeconomic status, or institutional affiliation. It is the discussions informed by these differences—whether between a mediator and a litigator, or a younger or more “seasoned” professional—that are the true strength of AFCC. In more than 30 years with AFCC, I have witnessed, participated in, and intentionally created many of these conversations, sometimes to my (and AFCC's) detriment, but more often to the benefit of those involved and others.

I hope that as many of the seasoned members of AFCC move on, that when the 70th or 75th anniversary is celebrated, our successors will have continued the legacy of an outstanding journal, practice guidance for professionals and programs, and amazing conferences that continue to engage and energize AFCC members. But most of all, I hope for continued, respectful, and fervent disagreement.

Looking forward to celebrating with you in Los Angeles.
